

I would like to inform you that PT provider UCLSB/SSLSB has been accredited according to EN ISO/IEC 17043 since December 2013 by SNAS (Slovak National Accreditation Service).

Every year we organize **two** PT schemes with two products each and different parameters. Our projects are called Interlaboratory Technical Project MC (month)/(year), for example MC 01/2016. The duration of the Pt scheme is 6 months: 3 months for collecting the applications, 1 month for sending the samples, 2 months for getting back the results and sending the reports and the certifications for participation.

Our activity as a PT provider started in 2008 and as an accredited one – in the end of 2013. He had more than 200 laboratories participating in our projects from over 10 countries for the last 2 and a half years. We are now planning extension of our scope of accreditation in order to satisfy the growing needs of our participants.

***Note: We send the report from the first project in the first week of July every year and in the first week of January (every year) for the second project. Two to three weeks later we send the English version of the report which is free of charge. Also our participants do not pay for receiving of the samples, invoices, certificates and so on. It is all included in the price.**
